This is regarding Compliance Report submitted by Government Polytechnic for Women, Kandaghat, Distt. Solan, Himachal Pradesh - 173215 for the Diploma Mechanical Engineering program which was accredited by NBA for academic years 2019-20 to 2021-22 i.e., upto 30.06.2022.

2. An Expert Team conducted onsite data verification of the program on 30th September, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for further 3 years. **Government Polytechnic for Women, Kandaghat, Distt. Solan, Himachal Pradesh - 173215** should submit fresh online application through eNBA portal in new SAR January, 2019 document at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Government Polytechnic for Women, Kandaghat, Distt. Solan, Himachal Pradesh - 173215** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. 
